Dear Dr. Mallett,

Everything that I am sharing with the public about my time travel experiences in DARPA's Project Pegasus is true.

The US defense-technical community achieved teleportation-based time travel in the late 1960's and by 1970 was already involving a cadre of gifted and talented American schoolchildren in different forms of quantum access with a view to them becoming America's first generation of "chrononauts."

I was one of those children and was directly involved in some of the most advanced project activities that Project Pegasus undertook.

The forms of quantum access involved included not only Tesla teleportation but the chronovision pioneered by Ernetti, Gemelli and Fermi at the Catholic University of Milan in the 1940's.

As my truth campaign, Project Pegasus, unfolds, and my book about my experiences is published, current quantum physicists who hold that time travel has not yet been achieved or is impossible – including Hawking, Darling, Kaku, and Mallett – are going to be discredited as either individuals uninformed about the true nature and extent of US government advances in applied quantum physics or as paid government disinformants.

It is not my wish that this should happen.

You seem like a fine fellow and I admire your work in time travel. I insist, however, that you and your colleagues are mistaken about the history of time travel, because you don't have access to the classified files pertaining to secret government project activities in applied quantum physics that have been undertaken since the death of Nikola Tesla in 1943.

If you wish to begin a dialogue with me about what I know as a result of serving in the US time-space program at the time of its emergence, I am at your disposal.

Ideally, you would interview me at length about the different forms of quantum access that were undertaken by Project Pegasus under the aegis of DARPA.

I will tell you everything that I know and answer any question that you might wish to pose that I can answer as a result of my project experiences. My only stipulation is that I be able to record via video or audiotape the interview so that I will be able to later publish it.

Questioning by an advanced theoretician such as you of an advanced experimenter like me might cause a discovery to emerge in the public realm that has already been achieved but kept hidden in the secret one.

I am for real, Dr. Mallett. I am not perpetrating a hoax. I am sharing everything that I know about a set of activities by the US defense-technical community that actually took place.

Among the distinguished scientists that I met while serving on Project Pegasus as a child (1968-72) were Dr. Harold M. Agnew, Dr. Edward Teller, Dr. Emilio Segre, Dr. Stirling Colgate, and Dr. Iben Browning.

I can even show you the keloid scars that formed on my upper body resulting from the applications in quantum physics that the atomic research community involved me in under the direction of Dr. Agnew at the time that he was director of the Los Alamos National Laboratories [LANL] (1970-78).

Allied, there is much that you and I can do to achieve progress in public access to the different forms of time travel that the US government achieved 40 years ago but kept secret to the detriment of humanity.

Not allied, I am afraid that your talents and those of other brilliant and dedicated researchers in the field of time travel will be exploited by a government that urges you to identify the state-of-the-art in quantum access while simultaneously denying you access to the information that reveals it.

The quantum cover-up must end, Dr. Mallett.

Let's collaborate so that the quantum cover-up might end and so that humanity will be able to utilize teleportation as a means to achieve planetary sustainability in the 21st century.
